**SHARED SERVICES AGREEMENT**

**THIS AGREEMENT** made this 17th day of February, 2014

**BETWEEN: DELANCO FIRE DISTRICT No. 1**, located at 1800 Burlington Ave., Delanco, NJ 08074, hereinafter referred to as "Delanco,"

**AND: BEVERLY FIRE DISTRICT No.1**, located at 446 Broad St, Beverly, NJ, 08010, hereinafter referred to as "Beverly,"

**WHEREAS**, Randy Johnson is employed by both Delanco and Beverly and wishes to use the Fire Official vehicle owned by Delanco for the providing of services for Beverly in the capacity of Fire Official; and

**WHEREAS**, the entities have reached an agreement to allow for the use of the vehicle and various equipment contained therein provided Johnson is employed by both entities in the capacity of Fire Official.

**NOW, THEREFORE**, in consideration of the promises exchanged herein, it is agreed as follows:

1. Beverly shall provide payment on an annual basis of \$1,200.00 for the use of the vehicle by Johnson as Fire Official payable \$300.00 quarterly.
2. Beverly shall provide appropriate insurance covering Delanco as an additional insured relative to use of the vehicle by Johnson and be responsible for any damage to the vehicle and hold harmless and indemnify Delanco from any claims relative to use of the vehicle by Johnson while working for Beverly. The insurance premium for this vehicle is \$629.00 for one year, therefore Beverly will contribute one-half of the premium (\$314.50).
3. The agreement shall be approved by resolution of each of the entities.
4. This Agreement shall be effective upon signing, and shall be for a one year period commencing January 1, 2014 and shall terminate December 31, 2014.
