The Regular Meeting of the Board of Fire Commissioners was called to order by Chairman Kevin Mickle under the Provisions of the Open Public Meetings Law c.295, Public Laws of 1979 with a salute to the Flag of the USA on July 20, 2015 at 7:30 PM at Beverly City Hall, 446 Broad Street, Beverly, NJ.

CHIEF'S REPORT: Fire Chief Mike Johnson gave a verbal report and submitted a report from the engineer's Meeting on 7/16/15. Chief Johnson reported on his budget at the halfway point of 2015. He is working on lieutenant pre-plans, the dept checking hydrants and submitted dates for two department meetings to be published.

FIRE OFFICIAL'S REPORT: Fire Official Johnson was not present.

OLD BUSINESS: A letter was received from the EPT Fire Comm in reference to contract negotiations. The Commissioners will hold this document until next month's meeting when all members will be present.

The approval of membership applications will be put on hold to determine proper means to access background checks on the advice of the Commission's attorney. Recent applicant background checks have shown issues that warrant a letter from the Commissioner's legal counsel to the applicants. There are options to use the state police for background checks, but could require a three month waiting period. There is concern that an applicant may not want to wait that long and could go to another dept. Mr. Richards is working on this process.

NEW BUSINESS: Mr. Richards talked about the need for an id machine.

Ms. Richards moved, seconded by Mr. Richards to approve the purchase of an ID machine at a cost not to exceed \$2,000, which motion was carried by unanimous vote with two members absent.
