MINUTES

The Regular Meeting of the Common Council of the City of Beverly, County of Burlington, and State of New Jersey was held on the aforementioned date with the following in attendance: Mayor Randy H. Council President Bancroft called the meeting to order at 7:30PM.

CORRESPONDENCE

No correspondence was presented.

MAYOR/COUNCIL/STAFF COMMENTS

Councilman Lowden stated that Beverly's Historical Society holds an open house the first Saturday of every month, and that private tours can be given by request.

City Administrator Wolbert informed the Common Council of the following: the new weapons for the Police Department have been received and that officers will undergo training for same; the new street signs have been received and installation of same will shortly commence; the Public Works Department will be re-facing all stop signs; preparation of the budget is underway; all employee computers will be required to be updated; and that the City recently submitted a RFP for banking services.

Councilman Lowden inquired if the County will replace street signs at its intersections. Mr. Wolbert noted that the County is not responsible for street signs, and that all municipalities are responsible for the purchase of same. Additionally, Mr. Lowden inquired about the size of signs designating the miles per hour on County roadways as compared to municipally owned roads. Mr. Wolbert stated that there are factors specified within State law that determine the size of such signs.

MUNICIPAL COURT REPORT – January 2020

The above report was reviewed by the Common Council.

PUBLIC COMMENT

Ronald Paice, 527 Broad Street, inquired about the new employee hire per Resolution 2020-40, and whether the individual positions will be paid separately and if the positions are in conflict. City Administrator Wolbert explained that the employee will be paid for all positions in one annual salary and that the responsibilities of each position are congruent.

Bev Haaf, 124 Riverbank, stated that the Beverly Free Library serves both Beverly City and Edgewater Park, and that the library's information will be in the Beverly Bee this month under Beverly City's section.

John Haaf, 124 Riverbank, inquired as to the status of the elevator at the Municipal Building. City Administrator Wolbert stated that the check from the insurance company was recently received, which will allow work to commence on the elevator. Mr. Wolbert further noted that the mold remediation has been completed.

Daniel Cannon, 610 Bentley Avenue, questioned the denial of his request for a handicapped parking space in front of his residence at the previous Council Meeting. Additionally, Mr. Cannon inquired about a letter he received regarding turning Bentley Avenue into a one-way street. Mr. Wolbert clarified both matters, and noted that the one-way on Bentley Avenue had previously been approved by the Common Council.

ADJOURNMENT

A motion was offered by Councilman Schwedes and seconded by Councilman Lowden to adjourn the meeting. Motion carried. The meeting adjourned at 8:13PM.
