The Endeavor EMS Report for March 2023 was reviewed without comment.

PUBLIC COMMENT

Andy Russell, 608 Manor Road, complained about truck traffic on Manor Road. City Solicitor Coleman noted that, under most circumstances, the City is legally not permitted to regulate truck

traffic on residential roads.

Barbara Russell, 608 Manor Road, complained about the lack of traffic enforcement along Manor Road, and inquired about the missing swings at the playground on Broad Street. City Administrator Wolbert noted that the swings, which had to be specifically ordered to comply

with the City's insurance requirements, have been on order but are delayed.

Beverly Haaf, 124 Riverbank, noted upcoming events at the Beverly Free Library, and expressed

condolences for the passing of Mr. Marable, who was also a trustee of the library.

Jeff Weisinger, 44 Pine Street, thanked the Police Department for their quick response in regards

unpermitted solicitors.

Ana Coleman, 41 Pine Street, noted that the tractor trailer trucks parked along Railroad Ave are

impeding visibility at the intersection of Bentley Ave.

Joe Heether, 603 Wheatley Ave, inquired about the shredding event on May 11th.

Kelsey Snively, 132 Riverbank, noted upcoming events of the Haaf Family Arts Foundation.

Karen Weisinger, 44 Pine Street, inquired about the public auction for 20 Pine Street.

There being no further comments, a motion was offered by Councilwoman Williams and

seconded by Councilman Dale to close public comment. Motion carried.
