RESOLUTION 2026-1
ESTABLISHING THE 2026 MEETING DATES, TIME, AND LOCATION

WHEREAS, the “Open Public Meetings Act”, N.J.S.A 10:4-6 requires that every Public Body must provide the Public with Adequate Advance Notice of all its meetings by either “Annual Notice” or a “48 Hour Notice”; and

WHEREAS, said Act further requires that both the “Annual Notice” and the “48 Hour Notice” must be (1) Prominently posted in at least one public place reserved for such announcements; (2) Transmitted to two newspapers in time for publication 48 hours in advance of the meeting; (3) Filed with the appropriate Municipal or County Clerk or the Secretary of State if the Public Body has Statewide authority; and, (4) Mailed to any person requesting a copy of same, upon payment for said copy.

NOW, THEREFORE, BE IT RESOLVED by the Land Use Board of the City of Beverly, County of Burlington, State of New Jersey that its regularly scheduled meetings for the 2026 Calendar Year shall be on the fourth Wednesday of each month unless indicated otherwise* as follows:
